
All grants made by us are subject to our supervision and control in accordance with our requirements. **Please note that we do not issue grants in amounts under \$500.** You will receive your first grant, and future grants, only after your account has accumulated a balance of at least \$500.

If it would assist you, we can supply you with a limited number of our Annual Report as well as our U.S. Tax Exemption letter. If you wish, you may prepare a form such as the attached or you may include in your brochure a statement such as the following:
